Top 5 Set For Brunswick Shootout Skins Game

Thursday night's Brunswick Shootout saw some terrific matches between some very good players, and the top five will earn at least \$1000.

The top five survivors for Sunday's \$15,000 Brunswick Skins Game Shootout Final Game are Allen Woolums and David Falconi from the 39 and under division, Storm DeVincent from the 40-49, Mike Truitt from the Senior Division and Murray Hickman representing the 205 and under average group.

In the final matches, Woolums defeated Brad Kiszewski 238-201, Falconi defeated Steve Smith 183-158, DeVincent defeated Tim Weisbrod 242-205, Truitt defeated Larry Hoffman 237-169 and Hickman defeated Jay Tomasello 190-189.

In the semi final round, the crowd was focused on the Mike Truitt/Wayne Crane match. Using a Brunswick Monster Frenzy ball, Truitt rolled a perfect 300 game to win 300-207. It was the 7th 300 of this year's Super Mini.
