First Vice President Andrews: My committees are: Audit, Budget & Finance, BVL, Program Evaluation, and Policy & Procedure. Thanks to those who serve on those committees. We have collected a little over \$15,000 for the BVL and hope to do as well as we did last year.

President Dale: Most of the following information has been chronicled in *BOWL Magazine*, but it bears repeating here. Some of the things this association is doing for the youth: We gave out in scholarship money — \$5,100 to the City Tournament; Youth Scratch Invitational, \$2,400; Youth 600 Club, \$3,500; Vern Burke, \$3,100 at the November event, and there is another scheduled for April 20, 2008. All of this is done without corporate sponsorship. We also have the Youth Star Award, which recognizes meritorious service and bowling achievement of our youth bowlers. The recipients each will receive \$200 and have their name engraved on a plaque. This year, Allen Windsor and Eric Helmrich were selected in the bowling achievement category and Adam Mitchell in the meritorious service category.
