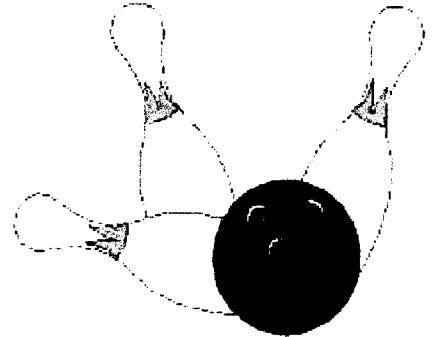
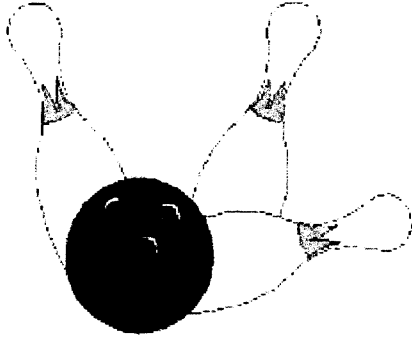

- USBC Tournament rules and regulations will govern this tournament.
USBC certification #05447
- The tournament is open to all USBC youth members certified in a NCAUSBCA certified league.
Bumper bowlers must be certified and bowl in a certified bumper league.
- The tournament will be divided into 6 divisions based on average –
Div 1 -Scratch; **Div 2** – HDCP (165 & above); **Div 3** – HDCP (135-164);
Div 4 – HDCP (100-134); **Div 5** HDCP (99 & below); **Div 6** – HDCP (Bumper)
- All bowlers in Div 1 thru 5 will bowl 3 games. Bowlers in Bumper Div 6 will only bowl 2 games
- Bowlers may participate in both squads. A second entry form with fee must be submitted.
Bowlers may only place once in each division. The highest series score will be used.
- The 10:00AM squad has limited slots available - Pre-registration is suggested for this squad.
Walk-ins will be allowed on a space available basis. Please pre-register to guarantee a spot.
- • Entering averages will be based on the highest book average from the '11/'12 NCAUSBCA Final Average Book.
 - For those without a book average, the highest current NCAUSBCA certified Youth League average as of October 31st, 2012 based on a minimum of 12 games, will be used. (This does NOT include games bowled on Sat. Nov. 3rd)
*A Standing Sheet as of that date must accompany this entry form.
 - If neither of the preceding apply then the highest current league average on November 10th, 2012, based on a minimum of 12 games will be used.
*A Standing Sheet must be brought to the tournament and given at time of check-in.
 - If none of the preceding apply then a tournament average of 200 will be assigned.
120 for bumper bowlers.
- Summer averages are not accepted for this tournament.
- Falsification of average will result in disqualification of the bowler.
- Handicap will be 100% of 200 for Divisions 2-5 and 100% of 120 for Bumper Division 6.
- Entry fee will be \$25.00 per bowler for Div 1 thru 5. Lineage \$8.25, Award fee \$16.75.
Entry fee will be \$20.00 per bowler for Bumper Div 6. Lineage \$5.50, Award fee \$14.50.
- All awards will be scholarships, which will be administered by SMART #9559. Scholarships will be presented 1 for every 10 entries in each division. Award fee will be returned 100%.
- Protests and appeals must be in writing stating the grounds for the protest or appeal and must be filed within 72 hours of the infraction. See Rule #329 in the rulebook.
- Entries must be postmarked by **November 5th, 2012** for pre-registration.
- *There will be a \$25.00 fee for all returned checks.
