1. USBC Tournament rules and regulations will govern this tournament.
USBC certification #05883
2. The tournament is open to all certified USBC youth members. Bumper bowlers must be certified and bowl in a certified Bumper league.
3. **DRESS CODE** – This tournament follows the Association Youth Tournament Dress Code, Tier 2. Please see attached, or view online via website/Facebook.

*Bumper bowlers are exempt from this dress code
4. The tournament will be divided into 6 divisions based on average –
Div 1 -Scratch; **Div 2** – HDCP (165 & above); **Div 3** – HDCP (135-164);
Div 4 – HDCP (100-134); **Div 5** HDCP (99 & below); **Div 6** – HDCP (Bumper)
5. All bowlers in Div 1 thru 5 will bowl 3 games. Bowlers in Bumper Div 6 will only bowl 2 games.
6. Bowlers may participate in both squads. A second entry form with fee must be submitted. Bowlers may only place once in each division. The highest series score will be used.
7. Entering averages will be determined from www.bowl.com and based on the highest Fall/Winter average from the 2014-2015 season with a minimum of 12 games.
 - For those without a Fall/Winter average, Summer averages will be considered, provided that a minimum of 12 games were bowled.
 - *For those without a 2014-2015 average, the highest current certified Youth league average as of November 21st, 2015, based on a minimum of 12 games, will be used.

*A Standings Sheet must be brought to the tournament and given at time of check-in.

 - If none of the preceding apply, a tournament average of 200 will be assigned.
Exception for Bumper bowlers: an average of 120 will be assigned.
8. Falsification of average will result in disqualification of the bowler.
9. Handicap will be 100% of 220 for Divisions 2-5 and 100% of 120 for Bumper Division 6.
10. Entry fee will be \$25.00 per bowler for Div 1 thru 5. Lineage \$9.75, Award fee \$15.25.
Entry fee will be \$20.00 per bowler for Bumper Div 6. Lineage \$6.50, Award fee \$13.50.
11. All awards will be scholarships, which will be administered by SMART #9559. Scholarships will be presented 1 for every 10 entries in each division. Award fee will be returned 100%.
12. Protests and appeals must be in writing, stating the grounds for the protest or appeal and must be filed within 72 hours of the infraction. See Rule #329 in the USBC rule book.
13. Walk-ins allowed on a space-available basis. Please pre-register to guarantee a spot.
14. For pre-registration - Entries must be postmarked by **November 16th, 2015.**
15. *There will be a \$25.00 fee for all returned checks.
